Dear Valued Customers,

We hereby give notice that our HSBC Amanah Perks@Work Programme Terms and Conditions ("Terms and Conditions") have been updated, latest version being February 2024 effective 1 February 2024.

The salary Criteria for Opening/Maintaining a Premier Account-i and Everyday Global Account-i (Premier Recognition) has been revised from minimum monthly gross salary of RM16,500 to minimum monthly gross salary of RM20,000. Please find below the changes made to Table A Clause 3 of Terms and Conditions:-
